### 8. TECF Matters: Report of TECF Matters by Natural Infrastructure Officer

#### a. National Marine Management and Marine Planning

The **National Steering Group** (NSG) for Marine Protected Areas (MPAs) met in February 2017, but minutes have still not been received.

All proceedings and papers of the NSG group would be available on the DEFRA website, and they asked that they remain a standing item on all relevant agendas [eg PPMLC and TECF].

**Marine Planning:** the MMO's consultation on their draft policies has now closed, and the workshop held in March provided an opportunity to further refine the draft policies.

The comments will now be reviewed over the remainder of the year, with the next iteration due in April 2018. The timetable remains unchanged.

#### b. Plymouth and SW Devon Plan, Waterfront Vision and Local Greenspace Designations.

The Draft Joint Local Plan consultation has now closed. Over 2,500 comments were received and these are currently being reviewed.

This includes the proposal to designate a number of Local Greenspace Designations, which will then have the same protection as greenbelt.

The next stage is for final submission to the Planning Inspector and this is due at the end of July, with a view to adoption either later in 2017 or in early 2018.

#### c. European Marine Site Managing Recreational Impacts Programme

Beth Siddons has been successfully recruited to the post of Natural Infrastructure Officer (Recreational Impacts) on a three year employment contract which started at the beginning of April.

The project has a comprehensive programme of work attached to it and Beth will give a quick presentation on her priorities for the project period.

**d. HRA Recreation Study**

The Recreation Study has now been completed by the MBA and includes analysis of:

- Four seasons of slipway surveys at 20 locations.
- Workshops for anglers, sailors, divers and canoeists
- Analysis of the online survey which collected 650 responses.

The purpose of the work was to establish the 'Zone of Influence' of the EMS and the findings are similar to those of other sites.

The next stage will be to use the data to inform the Strategic Access and Management list of actions required and then to agree the 'Zone of Charging' for the planning obligations.

Other data will need to be incorporated into this, including the RYA yachting data.

The reports are available on the TECF website.

**e. Tamar Estuary Biosecurity Plan Development Project**

The first outline Plan has now been drafted and was scrutinised at the workshop held at the beginning of March which was well attended. The Plan will set out an estuary wide approach to managing non-invasive marine species but one of the key areas that needs to be confirmed is the reporting procedures and which organisation keeps hold of the central data. This will be further discussed at TECF before the Plan is released and implemented.

**f. Slipway Audit**

The Slipway Audit will be completed by the end of June and will be available online.

**g. Developments**

**PLYMOUTH**

**Drakes Island:** The application is approved subject to final signoff of the legal agreements.

**Plymouth Hoe:** PCC is proposing to repair parts of the Hoe and will be removing a large concrete block from the foreshore – on-going.

**Mount Batten Ferry Pontoon:** This is due to be replaced with a new brow and pontoon to cater for the Mount Batten ferry and will be completed by October.

**Discharge Consent for Sewage Works:** SWW have requested changes to their discharge consent whilst they undertake improvement works to the Central STW.

**Wave Pontoon at King Point Marina:** A MMO license has been granted, and a condition discharge is being considered by PCC to replace the wave protection structure.

**Cremyll landing jetty:** Improvements are due to take place here.

**Devils Point:** there are proposals to repair the footpath following the landslip that took place a couple of years ago.

## Natural England Update

PPMLC Meeting 8<sup>th</sup> June 2017

### Priority issues in the SAC

Our condition assessment carried out last year highlighted some priority issues to tackle within the Special Area of Conservation which may need management action. These are issues that are causing parts of the site to be classed as in 'unfavourable' condition. With partners we have begun working on some of these issues including:

- Engagement and training for volunteers to manage and monitor the spread of Pacific oysters in the Yealm estuary.
- Tamar biosecurity plan: C2W consultants, working with the Marine Biological Association and Plymouth Marine Laboratory have produced a draft biosecurity plan for the Tamar funded by Natural England. A workshop was held in March which was attended by stakeholder representatives from marine industries and other key stakeholders from the Tamar Estuaries Consultative Forum (TECF) to develop the draft biosecurity plan. The draft plan has been updated following input from the workshop participants, and submitted to TECF. Actions likely to be adopted include:
  - Encouraging stakeholders to develop and share biosecurity plans for their own sites
  - Provision of training in Non Native Species (NNS) awareness and identification for local stakeholders
  - Promoting public awareness of NNS and the Check-Clean-Dry campaign, for instance by placing new signs in places frequented by the relevant stakeholders
  - The development of an information network for stakeholders, including e-mail alerts of significant local sightings of NNS
  - The development of rapid-response control and eradication procedures for newly-detected NNS, if feasible.
- Funding has been found for this year to continue the programme of eradication of Giant Hogweed in Tamar Valley to avoid it spreading along corridors into other publically accessible areas where it can cause injury. This is joint work with the Tamar Valley AoNB and the Environment Agency

## Plymouth EMS and Tamar Estuary Sites MCZ Monitoring

**Intertidal rocky shore monitoring 2016** – This is currently being reported on and will be shared when available.

**Intertidal habitat mapping** – This 'biotope survey' of all the intertidal areas of the SAC is planned for this summer. Once a contractor is appointed we will make contact with all landowners to ask for access permission. The report will look at change over time in areas where we have previous mapping data from a survey in 2010.

**Subtidal reef survey** – This will focus on the deeper (circalittoral) areas of reef within the SAC and is being carried out by Natural England's monitoring team in July.

**Allis shad and smelt surveys** – The Environment Agency are carrying out spawning surveys on our behalf at the top of the Tamar estuary to improve our knowledge of how these two migratory fish species use the site. Further surveys in the lower estuary are planned for later in the year.

**MPA exhibition** – Natural England and JNCC will have an exhibition on Marine Protected Areas at the National Marine Aquarium over the summer holidays, it will have a focus on local sites around Plymouth. Please come and see us if you get a chance.
