Agenda Item 6 Natural Infrastructure Officer's TECF Report Item for Information

1. Marine Planning

Marine Planning: TECF hosted a workshop for the MMO on 12 April at which they presented their approach to developing the Marine Plan and stressed that they would be looking for a thorough consultation with local stakeholders and that TECF and PPMLC would be both be important in this process.

The next stage will be their call for evidence which is over the coming months at which they are also looking for information on the challenges, opportunities and needs for each plan area over the next 20 years and how marine plans could address these. At the Plymouth workshop to be held on 19 July, they will also be showing the work they have done to date and will be demonstrating their Marine Planning Evidence Base. 2. Feedback from National MPA Steering Group Meeting

No further minutes from the National MPA Steering Group have been published since February. The last meeting was held at the end of June and the minutes have not yet been published.

3. Interreg / Other Funding Projects

PCC and TECF has recently been involved in putting forward project ideas to a joint Plymouth and Exeter University bid for NERC funding. We will hear in the next few months whether this will be successful.

The EU Horizon project which we recently submitted has been refused. The guidance we are currently receiving is not to resubmit.

4. Plymouth & South West Devon Local Plan and Local Greenspace Designations

Plymouth and South West Devon Joint Local Plan: The three local authorities have now agreed to produce the Plymouth and South West Devon Joint Local Plan which will be single strategic plan dealing with land use and development across Plymouth, South Hams and West Devon. It will set out proposals that will balance the needs for housing, employment and the environment through to 2034.

The public consultation launched on 1 July, will run to 12 August is seeking comments on:

- An overall approach to development which will focus growth into the city and also land immediately around Plymouth—while planning for the towns and villages to grow to meet local needs
- There is an overall housing requirement of 30,300 homes between 2014 and 2034, being distributed across the city, towns and villages. This assumes 21,000 homes being developed in and around the city; 8,700 homes being in the towns and villages and 600 being within Dartmoor National Park.
- Proposals for how the 8,700 homes might be shared across the towns and villages of South Hams and West Devon
- Details of potential sites for development in towns and larger villages
- How Neighbourhood planning will play a key role in delivering the approach
- The greenspaces and blue spaces that will be protected.

Local Greenspace Designations: Through the Local Plan-making process, Plymouth City Council is also putting forward sites to be designated under the new 'Local Greenspace Designation'. Waterfront sites which are being put forward include:

Plymouth Landscape and Seascape Assessment Draft Report: The includes the Plymouth Landscape and Seascape Assessment Draft Report which identifies areas of 'undeveloped coast'. In our area this includes parts of Jennycliff and Saltram.

This will be followed by a more formal consultation on a detailed plan in the autumn – leading to submission of a finalized plan early in 2017.

Plymouth Waterfront: The consultation includes the draft Plymouth Waterfront Strategic Masterplan, which sets out the priority themes of:

- Sights and sounds
- Working Waterfront
- Improving Waterfront Experience
- Connecting Waterfront Neighbourhoods
- A World Class Waterfront.

Major interventions are proposed at Hoe Park and Foreshore and also Sutton Harbour. Key interventions are:

- Introducing a coastal design language with the use of constant design palatte, more lighting, delivering a linear park along The Hoe and improvements to the Foreshore.
- The report proposes to introduce feature lighting and a new foreshore lighting scheme which could link the waterfront together.

Plymouth Sports Strategy: PCC has commissioned a piece of work to look at developing a sports strategy for the city and as part of this they will be looking at marine sports. The consultants who have been appointed will be meeting with key stakeholders over the coming months.

Confirmation is now in place for most of the funding and invoices will be issued shortly. We currently have £26,800 in the reserve, so TECF can carry on for the moment, subject to funding being secured from the other core partners. £5,000 of this will be used for the Community Seagrass Initiative's eco-friendly mooring trial.

Priorities for this year will include the following;

- 1. Stabilise funding
- 2. Mid-term review of the management plan in light of Reg 35 Conservation Advice update and emerging issues relating to BREXIT.
- 3. Continue to host TECF, PPMLC and TOFF meetings.
- 4. Recreation Study for the Habitats Regulations Assessment and drafting of findings to inform strategic planning documents.

- 5. Secure funding and deliver CIL EMS Project.
- 6. Contribute to the National EMS Group to support coordinated approach to management and to support coordination of South West marine plans.
- 7. Continue to provide marine planning advice to local planning authorities.
- 8. Produce a generic Non-native marine invasive species plan for the Tamar.
- 9. Support the production of the Cornwall Environment Strategy
- 10. Renew 4 TECF Information boards.

6. EMS CIL Funded Project Proposal

The NIO is in the process of securing £264,000 from PCC's Community Infrastructure Levy and S106 funds to deliver the requirements arising from PCC's Habitats Regulations Assessment for its last Core Strategy.

This programme will enable the Council to meet these legal obligations in its role as Competent Authority under the Habitat Regulations by delivering the identified assessment and management actions.

If successful, the programme will be delivered through two projects over a period of three years.

- Project 1 Research and Assessment:
- Project 2 Changing Behaviours.

It is proposed that the two projects are managed through a TECF Working Group. In practice this will be through liaison with key officers where relevant and then progress will be reported through TECF.

7. HRA Recreational Impacts Research

The Marine Biological Association are now undertaking the site surveys using MBA students. They will also be carrying out workshops wit targeted groups such as sailors, anglers and divers. The spring surveys have now been completed and work is underway on the summer surveys. Already they are providing very useful information on where people are coming from to use the water and it will be interesting to see how this changes over the season.

This work is being carried through funding provided by PCC, SHDC, CC and WDBC.

Slipway Audit

This is being dealt with under a separate agenda item.

8. Little Egret Research Group

Work is continuing with Plymouth University and NE in order to secure some more detailed research into Little Egrets and to get better understanding on how they are using Plymouth Sound and the Tamar Estuaries.

A three year research project is currently being put together and once complete, funding will be sought.

9. Community Seagrass Initiative

Some years ago, TECF agreed to contribute £5,000 towards the Community Seagrass Initiative which is being run by the National Marine Aquarium, in order to test eco-friendly moorings in Plymouth Sound and the Tamar Estuary. Work is about to start on replacing a mooring in Cawsand with a new design which uses floats to keep the chain off the sea bed which will then be monitored to assess its effectiveness.

10. Water Quality

Bathing waters: Bathing waters so far this year have been good. The early warning system is once again in use.

Natural England Update TECF Meeting 14th July 2016

Natural England staff changes

David Marshall continues as Marine Team Leader with three Senior Advisors; Sangeeta McNair, Andrew Knights and Rhiannon Pipkin working across Devon, Cornwall and the Isles of Scilly.

Angie Gall has recently returned from maternity leave as site lead for Plymouth Sound and Estuaries SAC. Hugh Tyler is the site lead for the Tamar Sites SPA. Marine Advisers in Cornwall are Liz Bailey and Carolyn Waddell.

Andrew Stanger has now moved to the Devon team based in Exeter and will lead on the Exe Estuary.

Natural England's Conservation Advice on Marine Protected Areas

The <u>Tamar Estuaries Complex Special Protection Area (SPA)</u> advice package has now been published on our Designated Sites System. The published site information and supplementary advice is available on this interactive web-based system. The final advice package was produced taking into account the stakeholder feedback received during the consultation. It includes information on seasonality of features. There is still work ongoing on the 'advice on operations' section of the packages and by the end of the year this section should be fully interactive as well.

Thank you for the comments regarding the advice packages for Plymouth Sound and Estuaries Special Area of Conservation (SAC) and Tamar Estuaries Marine Conservation Zone (MCZ), we are working through comments received before publishing later this year. These draft packages are not yet on the Designated Sites System but when they are finalised they will become fully interactive like the SPA advice.

Plymouth EMS and Tamar Estuary Sites MCZ Monitoring

Intertidal rock monitoring – This summer Natural England is conducting a survey of the extent, biotope composition and distribution of intertidal reef within the Plymouth Sound and Estuaries Special Area of Conservation (SAC). A brief walkover was conducted in 2010, however a survey of the entire site has not yet been completed. There is a known Pacific oyster presence; however the impact on site features is unknown. The surveys will also inform our SSSI condition assessment as many of the areas of intertidal rock are SSSI features. Any assistance with permissions and information on access to the shore would be much appreciated.

Neighbouring site Whitsand and Looe Bay Marine Conservation Zone (MCZ) - a dive survey is planned to assess the seagrass beds within this site.

- MLA/2013/00462 Sutton Harbour Boardwalk Development ongoing

Natural England continues to work with the Natural Infrastructure Officer on developing mitigation for increased recreational pressures resulting from the local plans. We have just secured £4000 of 'innovation funding' for TECF to contribute to our joint work in on mitigation.

Condition Assessment

Under the Habitats Directive the UK is obliged to report on the Favourable Conservation Status of Annex I and Annex II features to the EU every 6 years (Article 17 and Article 12). Natural England is currently in the process of revising how we assess and report on the condition of our marine protected areas including SACs, SPAs and MCZs.

Plymouth Sound and Estuaries SAC trial

Plymouth Sound and Estuaries was selected as a trial site for this new methodology and we completed a condition assessment at the end of March 2016.

Overall findings of the Condition Assessment were that large areas of Reef and Mudflats & Sandflats are judged to be in favourable condition, with Saltmarsh deemed to be 100% in favourable condition. Some parts of the Sandbanks, Estuaries and Large Shallow Inlets and Bays are in favourable condition but large sections have been assessed as in unfavourable condition due to a few key factors:

- The increasing amount of Invasive non-native species (INNS), particularly the slipper limpet *Crepidula fornicata*, and the Pacific oyster *Crassostrea gigas*, and the impact these species are having on the designated habitats within the site.
- Low infaunal quality index (IQI) in intertidal and subtidal sediments, indicating low biodiversity.
- Elevated sediment contamination in parts of the site.
- Elevated aqueous contaminants specifically in the Yealm estuary.
- Connectivity of the Tamar Estuary and the impact on the Allis Shad population within the estuary.

A report summarising the findings of this assessment has been provided to TECF and is available to anyone on request. In the near future the results will be displayed on the Designated Sites System alongside the finalised Conservation Advice package for the SAC.
